

CODE OF CONDUCT

 NYP is committed to ensuring that the campus remains a safe environment, where everyone is treated with respect and dignity.

• We encourage and expect high standards of conduct from all in our community. These expectations of responsible and appropriate behaviour are communicated in our Code of Conduct, available on the Student Portal.





• Let us be considerate, and respect all cultures, races and religions.

 We should all refrain from conduct that demeans, intimidates, threatens, harasses or injures any individual. This can include bullying, fighting, making derogatory remarks, and sexual misconduct (i.e. sexual assault, outrage of modesty or committing a voyeuristic act). SMOKING/VAPING

- NYP is a smoke-free campus, no smoking/vaping is allowed.
- The minimum legal age for smoking is now 21.
 Anyone caught smoking on campus or underaged smokers caught by NEA in any part of Singapore could face prosecution and disciplinary action by the Polytechnic.
- Vaping is illegal in Singapore (regardless of age).
 Simply purchasing, using or owning an e-vapouriser results in fines of up to \$2,000 per offence by HSA, and further disciplinary action by the Polytechnic.
- Existing evidence shows that Smoking/Vaping is addictive and harmful. You introduce many harmful chemicals into your body when you smoke or vape. Click here to find out the harmful effects of <u>Smoking</u> and <u>Vaping</u>.

DRUGS

It is an offence* to:

Traffick controlled drugs

Depending on the drug class and quantity, the penalty ranges from imprisonment and caning to the mandatory death penalty

Possess and consume controlled drugs

If found to be in possession, one shall be liable for imprisonment of up to 10 years, or a fine not exceeding \$\$20,000, or both

Consume controlled drugs outside of Singapore

Possess drug paraphernalia

Allow and facilitate drug activities

The Misuse of Drugs Act 1973

*The above list of offences is not exhaustive

If you...

- Suspect someone is involved in drug activities
- See someone abusing drugs
- Come across suspected drug items

You should...

- Avoid interacting with that individual
- Refrain from handling the items any further

SCAMS AND MONEY MULES

There is an increasing trend of Singapore students being scammed into selling their bank account details (Money Mules).

Approach

 Scammers contact students via Telegram or social media, offering easy money

Incentive

 Promise of monthly rental fees or large lump sums for bank account access. In many cases, victims receive no money, and the scammers become uncontactable after gaining access to the accounts.

Execution

•Students provide their bank details, including internet banking credentials and sometimes sign authorisation letters.

Misuse

•The scammers use the accounts for illegal activities, such as money laundering.

SENTENCING OPTIONS FOR YOUNG OFFENDERS

- To send a strong deterrent signal, probation and community-based sentences are not recommended.
- Imprisonment and reformative training should be considered instead, even for young offenders.

FOR JUVENILE OFFENDERS BELOW 16 YEARS OLD

Under the Children and Young Persons Act, they may face:

- O Probation between 6 months and 3 years;
- O Rehabilitation Centre for up to 3 years; or
- O Detention in the Boys/Girls'
 Home for up to 6 months

FOR YOUTH OFFENDERS 16 TO 21 YEARS OLD

The Sentencing Guidelines recommend:

- O Detention in the reformative training centre for at least 6 months; or
- O Prison term starting from 6 to 18 months

RADICALISATION

- Terrorism is a serious threat to the international community, including Singapore. According
 to the Ministry of Home Affairs (MHA), the domestic terrorism threat to Singapore stems
 primarily from self-radicalised individuals influenced by extremist materials online, and
 Singapore is vulnerable to attacks against soft targets by lone actors using easily available
 objects.
- The Institutes of Higher Learning (such as the Polys, Universities) have an important role to play by being vigilant to signs that someone in their community may have radicalised inclinations. Signs of radicalisation include, but are not limited to, the following:
 - a. frequently surfing radical websites;
 - b. posting/sharing extremist views on social media platforms, such as expressing support/admiration for terrorists/terrorist groups as well as the use of violence;
 - c. sharing their extremist views with friends and relatives;
 - d. making remarks that promote ill-will or hatred towards people of other races or religions;
 - e. expressing intent to participate in acts of violence overseas or in Singapore; and/or
 - f. inciting others to participate in acts of violence.



SEXUAL AND HURT OFFENCES

- The government has ramped up their efforts to clamp down on sexual and hurt offences, to provide more protection to victims of these cases.
- Offenders now face more severe penalties, regardless of their educational qualifications or academic potential.

BULLYINGWhat is Bullying?

An aggressive act with the intention to hurt a person on purpose. Bullying can take on the following forms:

Verbal Bullying

- A direct form of bullying where an individual is hurt or shamed through the use of words
- Examples: malicious teasing, insulting, ridiculing, intimidating or threatening

Relational Bullying

- An indirect form of bullying that causes harm to a person by damaging friendships and feelings of group acceptance
- Examples: spreading of rumours or gossip to damage the bullied's reputation, manipulation of friendships to blackmail the bullied, or purposefully excluding the bullied from group activities

Physical Bullying

- A direct form of bullying where deliberate physical aggression is used against an individual, or on his or her belongings
- Examples: hitting, punching, kicking, hair pulling, or taking away/ destroying the belongings of the bullied


Cyberbullying

- A form of bullying carried out through electronic means
- Examples: sending of malicious text messages and emails to the one being bullied, spreading rumours or gossips via text messages or social media platforms, or posting embarrassing images or videos of the bullied on social media platforms

NYP does not tolerate bullying in any form. Students engaging in any form of bullying are subject to disciplinary and punitive actions that can include expulsion.

ACADEMIC INTEGRITY

- As an educational institution, NYP upholds high standards of academic integrity. Dishonesty in any assessment is taken very seriously, and such offences will be dealt with in accordance to our NYP Academic Integrity Policy.
- Do also note that **facilitating cheating** is an offence. Students must ensure that they do not encourage or allow other students to copy. This includes sharing of assignments.

AI POLICY FOR LEARNERS

Purpose

This Policy provides guidance to learners for responsible and ethical use of AI tools and to ensure learners use the tools effectively in their academic work with clear understanding of the limitations, and to avoid contravening academic integrity.

<u>Scope</u>

This Policy covers the use of content generated by AI tools in academic work, including but not limited to all graded assessments.

(As Al tools are ever evolving, the Al policy will be reviewed and updated when necessary.)

AI POLICY FOR LEARNERS

1. Learners must:

- uphold academic integrity and always ensure quality of their academic work.
- evaluate the accuracy, credibility, reliability, currency and relevancy of the information generated by Altools.
- only use the AI tools to supplement their studies, clarify ambiguous concepts, and assist with research, in an ethical and responsible manner.
- properly cite the source and credit the AI tools in their academic work.
- display ethical and responsible use AI tools and properly cite the source and credit the AI tools in their academic work.
- be able to prove that they comprehend the output of the AI tool and know how to apply it in their academic work when being asked.

2. Learners must **not**:

- use AI tools for plagiarism or cheating by presenting generated output without proper acknowledgement of the original source.
- be over-reliant on AI tools.

AI POLICY FOR LEARNERS

3. Acknowledgement of use

Where content from AI tools are used, Learners must:

- use good referencing and citation, to paraphrase and acknowledge the original source by declaring the extent of use of AI tools and describe which tool was used and how it had been used.
- cite the specific Al-generated contents they have use or take work or ideas from (text, images, videos, audio, code, etc)
- submit both in-text citation and a reference list and explicitly declare the Author or Group Name of the Al tool, Date retrieved, Title of Work and URL.

4. <u>Consequences</u>

Taking and using the whole or any part of ideas, words or works of Al tools and passing it off as one's own work without acknowledgement of the original source is tantamount to Plagiarism. Such acts will be dealt with accordingly under the NYP Academic Integrity Policy.

PENALTIES

- > First Offence
- A candidate who, after due disciplinary process, is found to have committed an act that contravenes academic integrity in any assessment of a module/competency unit/competency unit shall fail the module/competency unit. The candidate shall be given an 'F' grade for the module/competency unit with a corresponding grade point of 0 (Zero (0) mark).
- > Second Offence
- A candidate who, after due disciplinary process is, found to have committed an act that contravenes academic
 integrity for a second time in his/her candidature in NYP shall be deemed to have failed all the registered (but
 uncompleted) module/competency units. The candidate shall be given an 'F' grade for these module/competency
 units with a corresponding grade point of 0 (Zero (0) mark).
- > Third Offence
- A candidate who, after due disciplinary process is, found to have committed an act that contravenes academic integrity for a third time in his/her candidature in NYP shall have his/her candidature terminated. He/she shall be deemed to have failed all the registered (but uncompleted) module/competency units. The candidate shall be given an 'F' grade for these module/competency units with a corresponding grade point of 0 (Zero (0) mark).



PSYCHOLOGICAL RESPONSE TO A TRAUMATIC EVENT

- Talk to someone you trust and ask for help. The lecturers and PEMs are here to support you.
